

In Indiana, divorcing parents are often required to take a coparenting class as part of the divorce process. The purpose of this requirement is to promote the best interests of the children involved in the divorce and to help parents develop effective coparenting skills. The Transparenting (the co-parenting curriculum that is used) class aims to provide parents with information and tools to navigate the challenges of co-parenting after divorce or separation. Divorce can be a significant transition for children, and the class is designed to help parents minimize the negative impact of the divorce on their children's well-being and development.

FAQS

Q: How much does it cost?

The class is priced at \$60. You can pay in person at our main office in Valparaiso with cash or money order. For your convenience, you may pay online through our online registration site. Online payment may charge a small transaction fee.

Q: Where do classes take place?

Classes are held virtually. You will need access to internet/ wifi to attend the Transparenting class. The Zoom link will be emailed to you the day prior to the class.

O: What is the registration deadline?


The online registration window closes one week before the class to allow for book mailing. In person registration stays open one day prior to the scheduled class.

Q: What is the refund policy?

Full refunds can be made up to 7 days before event (minus online processing fees). Class materials must be returned prior to full refund.

Q: When will I get the Zoom link (link for the virtual class)?

The link will be sent out to you to the email that was provided during the registration process. It will be sent the day before the scheduled class. Please check your junk/ spam folder before emailing family focus about the zoom link.

Q: Do I have to take the class together with my child's parent?

No. Many times, separating couples prefer not to take the class with their child's other parent. You will have the ability to share this preference in the registration process.

Q: When will I get my certificate of completion?

Certificates of Completion will be issued within five business days of class completion. Registrants of the class are responsible for submitting documentation, including completion of class, to their attorney. A Family Focus administrator will submit a report to the County Clerk's Office, notifying them of completion of course.
